Investor Alert: Validated UPI Handles & SEBI Check Tool

Investors are requested to note that Morgan Stanley India Company Private Limited is permitted to receive money from investor through designated bank accounts only named as Upstreaming Client Nodal Bank Account (USCNBA) as listed above.

To address growing issue of impersonation, enhance investor confidence and prevent unauthorized fund collection, SEBI has introduced SEBI Check Tool and Validated UPI Handles, mandated a new UPI address structure for all SEBI-registered investor-facing intermediaries who collects funds from investors effective October 1, 2025.

What's New?

- Validated UPI IDs: All SEBI-registered intermediaries must use structured UPI handles for secure payments.

- Green Thumbs-Up Icon: Indicates a verified UPI ID linked to a SEBI-approved bank account.

- Verify UPI IDs by scanning a QR code or entering manually.
- Confirm bank account details (Account Number & IFSC) of registered intermediaries.
