## PRODUCT OVERVIEW

Renaissance Investment Management ("Renaissance") 3-Way Asset Allocation - Institution is a disciplined tactical asset allocation process. Through the use of quantitative valuation models, the domestic market alternatives of common stocks, bonds and cash equivalents are analyzed in terms of their valuation relative to one another. Through this relative value analysis, Renaissance determines which market alternative offers the best value at particular points in time and adjust portfolio allocation accordingly. Portfolios may be invested up to 100% in any of the three asset classes at any point in time. The stock portion of Three Way accounts is broadly diversified, and consists of large-capitalization issues that exhibit a combination of good valuation and strong earnings growth potential. Bonds are typically limited to Treasuries and high quality Corporates.

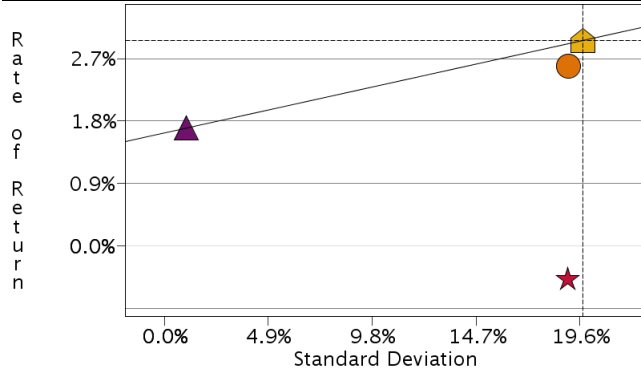

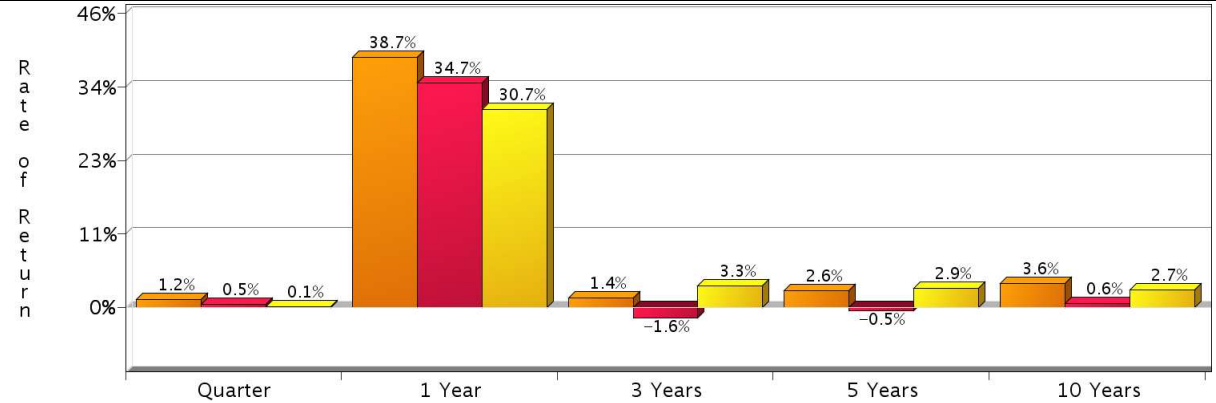

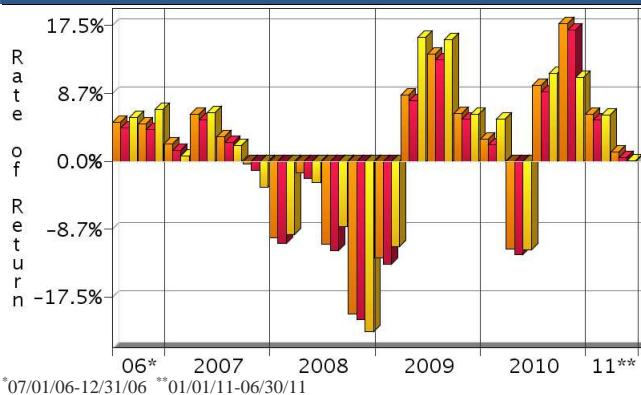
AVERAGE ANNUAL TOTAL RETURN (%) – PERIODS ENDING 06/30/11

Renaissance Investment Management ("Renaissance") 3-Way Asset Allocation - Institution Wrap composite on 1/1/1995 and it was redefined as of 1/1/2006 to include the historical fee paying, fully discretionary, non-tax managed, non-wrap Three Way Asset Allocation account returns from its inception on 1/1/1995-12/31/2005. From 1/1/2006 to present, the Three Way Asset Allocation Wrap composite includes all Three Way Asset Allocation fee paying, fully discretionary, non-tax managed, direct managed accounts with wrap fee arrangements and fee paying SMA accounts that adhere to the SMA sponsor's inclusion guidelines. The equity allocation portion of our Three Way Asset Allocation Strategy invests in large-sized companies exhibiting a combination of strong prospective earnings growth, reasonable valuation and good corporate fundamentals. The cash allocation is invested in short-term funds or treasury bills and the bond allocation typically consists of U.S. treasuries. This strategy only includes accounts that are reallocated in 50% increments between stocks, bonds and cash. Prior to 03/15/1995, the Three Way Asset Allocation Wrap composite contained taxable accounts and their historical performance. After that date, all taxable accounts were removed from the Three Way Asset Allocation Wrap composite and its historical performance. RIM does not have non-fee paying portfolios. The composite is asset-weighted and consists of 3 accounts with a market value of \$1.3 million as of 6/30/2011.

#### Fiduciary Services Performance:

**Net Performance for all Periods:** To demonstrate the effect of Morgan Stanley Smith Barney's fees that would have applied if you had invested in the investment manager strategy's through the Fiduciary Services program, the net results for all periods are calculated by deducting a quarterly fee of 0.75% (equivalent to an annual fee of 3%).

Morgan Stanley Smith Barney program fees are usually deducted quarterly, and have a compounding effect on performance. #### Focus List, Approved List, and Watch Status:

Consulting Group Investment Advisor Research ("CG IAR") uses two methods to evaluate investment products in applicable advisory programs. **INDEX DESCRIPTIONS****90-Day Treasury Bills**

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of 'discount' is the interest earned. T-bills are issued in denominations of \$10,000 (auction) and \$1,000 increments thereafter.

**S&P 500 Index**

Widely regarded as the best single gauge of the U.S. equities market, this world-renowned index includes a representative sample of 500 leading companies in leading industries of the U.S. economy. Although the S&P 500 focuses on the large-cap segment of the market, with over 80% coverage of U.S. equities, it is also an ideal proxy for the total market.

**GLOSSARY OF TERMS**

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Capitalization** is defined as the following: Mega (\$50.0 billion and Above), Large (\$11.0 - \$50.0 billion), Medium (\$2 - \$11.0 billion), Small (\$500m - \$2 billion) and Micro (below \$500 million).

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**R<sup>2</sup> (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.
