PRODUCT OVERVIEW

They believe that a disciplined, risk managed investment process is essential to outperforming the benchmark consistently. Their aim is to own stocks that they believe are attractively valued with improving business prospects because investors in such stocks can benefit both from rising expectations and from expanding valuations. They believe finding these types of stocks is best accomplished through a combination of quantitative analysis and fundamental research. Their goal is to offset the flaws they feel are inherent in each methodology and to produce a better combined result than either process alone. They also seek to control factors that can influence relative performance by constantly monitoring the sensitivity of the portfolio holdings (current and proposed) to both the benchmark and each other.

MANAGER'S INVESTMENT PROCESS

- The Rothschild U.S. Large Cap Value strategy uses a selection universe of about 1,050 stocks, including all stocks in the Russell 1000 index and others that are among the largest 1,000 U.S. stocks by market capitalization that are included in the S&P 500 index, or are already held in portfolios.
- Their investment team's proprietary ranking tool provides an objective and efficient way to narrow the investable universe to a group of stocks that they believe are likely to outperform the market. It is designed to identify stocks that are attractively valued and have potential to exceed investors' expectations. The four main factors considered are 1) relative valuation, 2) expectational upside, 3) earnings quality, and 4) short term price movement.
- Securities highlighted by the ranking tool (those found in the top two deciles) undergo rigorous fundamental research by the analyst responsible for the stock's assigned sector. The company is compared to its competitors on a variety of valuation metrics and subjective measures, such as influences on earnings, competitive position, and expected margin trends, to determine whether the valuation is attractive and whether trends are sustainable.
- Once the fundamental review is complete, the team member presents the case for or against approval to the full team, which may make a decision or request further research. Decisions to approve a stock for potential purchase are normally made by consensus, occasionally by majority vote.
- Once a stock is approved, the lead portfolio manager is responsible for determining whether it is an appropriate holding for the strategy. This decision is based on factors that include a stock's market capitalization, characteristics, and its potential effect of purchase sector weights.

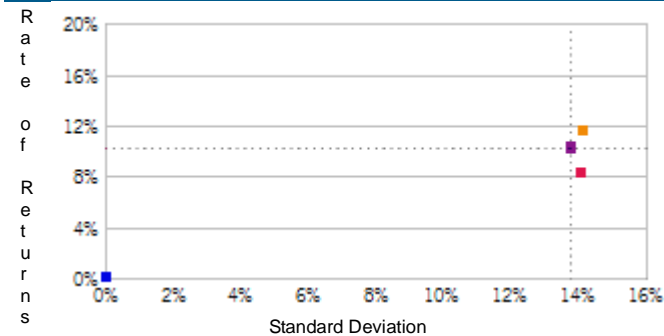

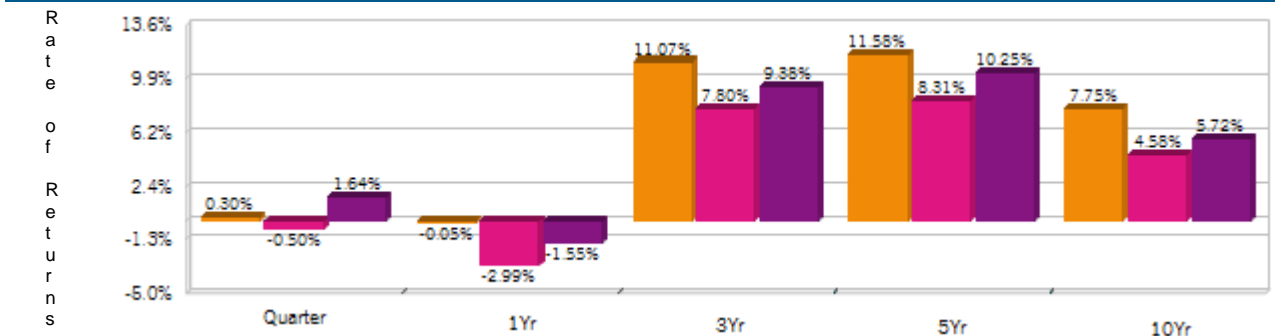

RISK/RETURN ANALYSIS - 5 YEARS ENDING 03/31/16



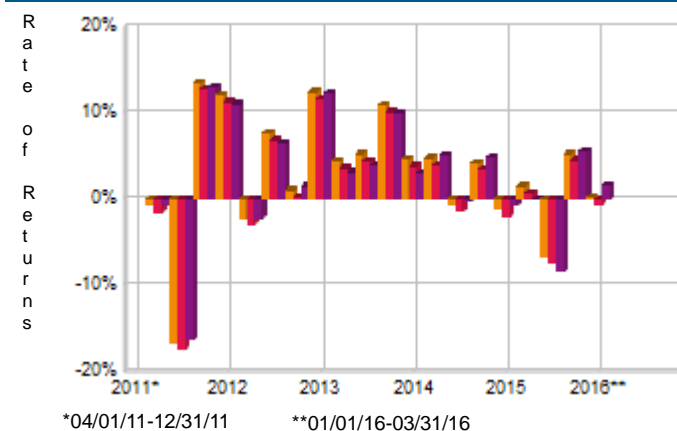

The Rothschild U.S. Large-Cap Value Composite consists of all discretionary, fee-paying accounts with no client restrictions on trading or stock selection using the Rothschild U.S. Large-Cap Value strategy, a minimum of \$2 million in total market value (market fluctuations will not cause removal), and a benchmark of the Russell 1000 Value Index. The Composite was created on October 1, 2000. Results for the full historical period are time-weighted, based on daily cash flow application. Composites are asset-weighted, using beginning-of-month market value. There have been no material personnel or other changes which would affect the Composite.

Fiduciary Services Performance:

From January 2012, performance consists of all Fiduciary Services accounts managed by the investment manager in the strategy, subject to any other limitations stated in this profile. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

Russell 1000 VI

The Russell 1000 Value Index is representative of the U.S. market for large capitalization stocks containing those companies in the Russell 1000 Index with lower price-to-book ratios and lower forecasted growth.

S&P 500

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depositary Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
