Further details are set out in the prospectus of the SICAV (the “**Prospectus**”).

Please note that the class J shares currently benefit from a temporary partial Administration Fee waiver (the “**Waiver**”). Such Waiver has been reducing the Administration Fee for all class J shares of the Fund to 0.10%.
